Public TV and the FCC Spectrum Auction: A Mystery and an Opportunity

Introduction

In the spring of 2016, the Federal Communications Commission began its long-awaited broadcast incentive auction — a major redistribution of the public airwaves. The FCC is urging television broadcasters to give up their channels or move elsewhere on the dial to clear large swaths of valuable spectrum. In return, the FCC is offering stations a hefty portion of the proceeds from auctioning off these newly empty channels to wireless companies.

The incentive auction presents a unique opportunity for communities. Across the country, state and local governments, along with public and private universities, hold noncommercial television licenses that are likely to be part of the auction. According to the FCC, some of these public-broadcasting licenses may be worth hundreds of millions of dollars, depending on their locations and the size of the populations they reach.

These are the public's airwaves, and their use has always come with public interest obligations. Public television stations stand to make a huge amount of money from the auction. Instead of using these revenues to fill short-term holes in state budgets or university endowments, those funds could be used to serve community-information needs. The Free Press Action Fund believes a significant portion of the proceeds could be used to support community-driven projects, responsive local journalism, serious investigative reporting and essential public media outlets.

While it's going on, the auction is something of a mystery. Participants are largely barred from talking about it or revealing their bidding strategies. Stations aren't required to say publicly whether they're participating in the auction — but they're not prohibited from doing so, either.

The Free Press Action Fund recently set out to determine which public TV stations are taking part. First we noted which stations had already publicly announced their intention to participate or not. Then in July, we contacted by phone all auction-eligible public broadcasters that had not yet publicized their plans. Here's what we found:

- 54 public TV stations confirmed that **yes**, they are participants in the auction.
- 87 public TV stations confirmed that **no**, they aren't participants in the auction.
- 40 stations **refused** to say whether they applied to participate.
- 104 stations didn't respond to the survey.

The participating stations the Free Press Action Fund identified are concentrated in 18 states and the District of Columbia. If they were to sell their spectrum at the maximum opening-bid prices, they would collectively stand to earn over \$14 billion.

How the Auction Works

The FCC's goal is to concentrate television broadcasters' use of spectrum inside a narrower band, then auction off the freed-up bandwidth to commercial interests, such as wireless companies.

The auction has two distinct parts. In the first phase (the "reverse" auction), the FCC will buy up bandwidth from commercial and noncommercial broadcasters, with a strategic eye toward opening up valuable swaths of the airwaves. In the second part (the "forward" auction), it will auction off the cleared bandwidth to wireless companies or other commercial bidders.

There are three ways broadcasters can take part in the auction. They can: 1) sell their licenses and stop broadcasting, 2) sell but maintain a signal through channel-sharing or 3) move "down the dial" from UHF to VHF channels. Some participating stations may eventually drop out during bidding as the FCC continuously lowers its offering prices.

The initial reverse auction was completed in June, with broadcasters across the country agreeing to clear 126 MHz of spectrum (the equivalent of 21 channels in each market) if they were paid a total of \$86 billion. The forward auction began in late August, but in its first round wireless carriers bid only \$22 billion to acquire the spectrum space.

To bring the broadcasters and wireless carriers closer together on a price, the incentive auction began its second round on Sept. 13, reducing its clearing target to 114 MHz to encourage wireless-carrier demand for the spectrum. The second reverse auction set a price of \$54.6 billion, but the second forward auction stayed steady at \$22 billion. Now a third auction stage must begin. If the two prices fail to match yet again, the incentive auction will move into subsequent rounds until the forward auction returns enough revenue to cover the costs of the reverse auction.

Many observers expect the process to be completed by the end of the year, though it will take much longer for the FCC to repack stations and distribute payments, a process that will stretch into 2017 and possibly beyond.

Solving the Mystery: Who's in the Auction?

The Free Press Action Fund began its survey of public TV stations with extensive online research about station plans to participate in the auction. Through that research, we confirmed the plans of 69 stations, including 29 that had joined the auction. In July, we contacted by phone all auction-eligible public broadcasters in the country that had not yet publicized their plans.

We confirmed the status of 72 additional stations. Of those 72 stations, 25 acknowledged for the first time publicly that, yes, they were participating in the auction. Another 47 said that they were not participating. Unfortunately, 103 stations did not respond to repeated calls and emails.

For the 40 stations that responded to our survey but would not reveal their plans, most explained their refusal to comment as a response to the FCC's anti-collusion rules. According to the FCC's guidance on prohibited communications (available here), reverse-auction participants are forbidden from sharing any information about bidding strategies to prevent collusion. "Bidding strategies" is a broad category that includes whether a station is still in the auction — however, the rules do permit stations to reveal whether they submitted initial applications to participate.

Even after we explained that we were asking only for information that would not violate the FCC rules, many stations claimed our interpretation was incorrect — or said the station had chosen not to share any information out of an overabundance of caution. Some referred to edicts handed down by stations' legal departments or university higher-ups. Some stations, including Oregon Public Broadcasting, refused to disclose their auction status but promised that none of their stations would go off the air.

One broadcaster, the Oklahoma Educational Television Authority, claimed the FCC had recently sent new guidance banning stations from sharing any information. No such guidance has been made public. At KRSU-TV, licensed to Oklahoma's Rogers State University, the receptionist simply informed the caller that there was no one there we could speak to, no one we could leave a message for, and no good time to call back.

Meet the Participants

So where are the public TV stations entering the auction located? Who owns them? And how much money do they stand to earn if they sell their spectrum licenses?

Using the <u>FCC's publicly released data</u> regarding opening-bid values, the chart below shows the top public TV stations in the auction by maximum opening-bid value. 4

This second chart uses the <u>same data</u> to show the top five states and top five markets (DMAs) that stand to earn the most revenue if all of their participating stations sell at their maximum opening-bid values.

Stations will likely sell for prices that are significantly lower than their opening bids, but these figures give a sense of just how much is at stake in this auction.

Investing in Local Communities

When the incentive auction finally closes its last round of bidding, the FCC will pay out potentially billions of dollars to participating public television stations that sell off their spectrum licenses. According to a <u>study commissioned by Public Media Co.</u>, these stations could earn up to \$6.8 billion in the auction.

State and local governments own some of these stations. Public and private colleges own others. As public broadcasters, these entities must meet certain public obligations, including providing educational and public affairs programming to serve their communities.

Right now communities across the country are struggling to find journalism that meets their needs and tells their stories. Traditional news outlets are in crisis, with decades of consolidation resulting in severe staffing cuts and reduced local coverage. Without consistent reporting on the issues that matter most, communities are less able to hold those in power accountable. Many public television stations could go off the air as a consequence of the spectrum auction, making it even harder for people to stay informed.

The auction is going to bring in hundreds of millions of dollars, some of which is already being earmarked to fill short-term budget gaps or shore up university endowments. The Free Press Action Fund believes the auction presents an opportunity to establish long-term support for responsive local journalism, innovative public media and other community-driven projects designed to meet local information needs. It's a chance to rebuild and reinvent local newsrooms across the country.

The Free Press Action Fund is launching a new campaign — starting in New Jersey and expanding to other markets — to educate the public about the opportunities the auction presents, develop proposals for ways this money could be used to serve community-information needs, and build the popular pressure and political will needed to seize on this once-in-a-lifetime opportunity.
